At the outset Dr. S. S. Solanki, Director Education, welcomed the Hon'ble Vice Chancellor, Dr. Balraj Singh and all the members, co-opted members and invitees in the meeting.

The Hon'ble Vice Chancellor, welcomed Co-opted members and other members and in his opening remarks stressed upon to adopt modern technology and innovative methods of pedagogy to create the interest of students in learning. He also urged to faculty members to develop new courses for imparting education on skill development. The Vice Chancellor also discussed on development of research technology which can reduce the cost of cultivation and enhanced income of farmers. In this discussion Dr. N.S. Shekhawat Co-opted member expressed his views and suggested to emphasized on to take up research aspects related to root biology, conservation biology and integration of water uptake, water use efficiency, tolerance and genomics. He stressed to initiate research in this direction to make next green revolution.

Dr. Shekhawat informed about the importance of Phog (Calligonum polygonoides) and urged that it should be planted by cutting at KVK, Malusar, for further studies and its usefulness as stress remover, enhancing organic carbon etc.

To accord permission for starting Post Graduate programme from academic session 2016-17 in AU, Jodhpur.

Resolution

Academic Council approved the agenda of initiating the post graduate program in the subject of Plant Breeding and Genetics, Agronomy and Horticulture in the College of Agriculture, Mandor, AU, Jodhpur, from the academic session 2016-17. The admission shall be given on the merit of Pre PG test and admission process be completed by the JET& Pre PG examination Coordinator. Intake capacity of students in each subject shall be four students. Out of these three seats shall be filled through Pre PG entrance test of Rajasthan State and one seat shall be filled by ICAR quota (25%). In case of non allotment of students from ICAR the vacant seat may be filled up through Pre PG test. The reservation etc. shall be as per the State Government policies. Till the Post Graduate Council is formed syllabus, examination, evaluation pattern etc. of MPUAT, Udaipur shall be adopted for running the PG courses in said subjects.

Consideration for increasing intake capacity in B. Sc (Ag) in College of Agriculture, Nagaur.

The intake capacity for admission in the first year B. Sc Ag in the College of Agriculture, Nagaur, shall be 50 seats. Out of these 34 seats will be of general types, six seats shall be for ICAR quota as per the norms of the ICAR, New Delhi, and 10 payment seats. The ten payment seats will be supernumerary in addition to earlier sanctioned intake capacity of forty students.

Professor, ARS, Mandor about the score card for the direct recruitment of Assistant Professor, Associate Professor, Professor etc. and promotion under Career Advancement Scheme (Astt. Prof. Stage I.T. &III., Associate Professor, Professor). The house approved the score card, qualifications, format of application forms for all the category of posts for CAS and direct recruitment. The hard copy of all score card shall be enclosed with the minutes to be circulated to all members for the comments if any.

- 1. Modification in the examination pattern and mid-term examination should be included in the examination. Proposed marking system is as, 20 marks (Mid), 30 marks (practical) and 50 marks (end-term) in total of 100 marks.
- 2. RAWE programme should be in 7th semester in place of 8th Semester, so that students can prepare for the competitive exam of PG etc.
- 3. Few seats in B.Sc (Ag) may be filled on merit basis. The MPUAT Udaipur is following this system. The minimum eligibility for applying in this category should be 85% in the senior secondary examinations.
- 4. Remuneration of coaches and officials may be increase from existing Rs. 150/- to 250/- per session.
- 5. Provision of kit for student participating in inter college tournament (Max. Rs. 500/-per student).
- 6. Teachers having additional charge of ADSW, Games In-charge and NSS related duties may be paid allowance of Rs. 500 per month.
- 7. To constitute university sports board. (Annexure-XIII-XIV).

3. Ten seats can be filled exclusively on merit basis for the admission in the B.Sc Ag (First year). The eligibility to apply under this category shall be minimum 80% marks in Senior Secondary examination (Science group, Maths, or Biology or Agriculture).
